Are your hospital construction plans up to code?
Every three years, California adopts a new set of construction codes. The 2016 California Building Standards Code (Title 24 California Code of Regulations) was published in July 2016 and became effective Jan. 1, 2017. That means all building permit applications submitted on or after Jan. 1 must be compliant with the 2016 code. Changes to the code are significant and broad in scope. Hospitals planning or considering new construction projects should not miss this informational three-part webinar series.

Representatives from the Office of Statewide Health Planning and Development (OSHPD) and Hospital Building Safety Board (HBSB) will outline important changes to the CBSC and explain what hospitals and their construction teams should consider to achieve compliance.
