

## NON-LICENSED HEALTH OCCUPATIONS

Revised May 2011

The following non-licensed health occupations are coded using the 2010 U.S. Department of Labor (USDOL), Bureau of Labor Statistics (BLS) Standard Occupational Classification (SOC) System. The SOC is used by Federal statistical agencies to classify workers into occupational categories for the purpose of collecting, calculating, or disseminating workforce data. The additional job titles included in each category were identified by the USDOL BLS Occupational Outlook Handbook and USDOL Employment Training Administration's Occupational Information Network (O\*NET On-Line). O\*NET On-Line is the nation's primary source of online occupational information. OSHPD will provide updates to this listing as changes are identified.
