


Psychiatric Technicians

November 2012



Psychiatric Technicians are licensed by the California Board of Vocational Nurses and Psychiatric Technicians (BVNPT). Psychiatric Technicians are entry-level practitioners who provide care for mentally disordered or developmentally disabled clients under the director of services. Duties within the scope of practice for a Psychiatric Technician typically include basic hygiene and nursing care, measurement of vital signs, performance of prescribed medical treatments, administration of prescribed medications, implementation of behavioral management techniques, crisis intervention, sensory and perceptual assessment, social and vocational training, and the facilitation of individual and group therapeutic activities. As of September 2012, there were 9,855 Psychiatric Technicians with active licenses in California.*








