Scope of OSHPD Preapproved Agency (OPAA) Program

- OSHPD Preapproved Agency (OPAA) Program is limited to:
 - Testing Agencies Accredited to ISO 17025 or Equivalent;
 - Special Inspection Agencies Accredited to ISO 17020 or Equivalent; and
 - Testing and Special Inspection Agencies approved under the California Division of State Architect (DSA) Laboratory Evaluation and Acceptance (LEA) Program (DSA-LEA Program).

Basis of OSHPD Preapproved Agency (OPAA)

Minimum Requirements for OPAA

- Testing Agency Accreditation in accordance with ISO 17025 or Equivalent;
- Special Inspection Agency Accreditation in accordance with ISO 17020 or Equivalent;

and/or

- DSA-LEA Approval.

Is the OPAA Program Limited to Structural Tests and Special Inspections Only?

- **Yes!**

Are the Mill Certs still Acceptable, where Specifically Permitted by CBSC?

- **Yes!**

Are the Special Inspection Agencies Approved through OPAA Program?

- **Yes!**

OPAA Submittal Requirements

1. Completed **application in word format with signature attached.**
2. Application or Renewal filing fee.
