



**Coming This Summer!
Public Comment Period**

An OSHPD Proposed Regulation package will be open for public comment later this summer. All MIRCal Contacts will be notified. To ensure you receive OSHPD Healthcare Data Regulation Updates, sign up on our [website](#).

Changes in this regulatory proposal to take effect with 2019 discharges and encounters include:

- ED/AS ZIP Code: Change to match IP ZIP Code format for reporting Homeless, Foreign, and Unknown.
- IP Race: Currently 1977 OMB standard – change to match ED/AS Race reporting (1997 OMB standard).
- Race: Allow up to five race choices for each patient.
- IP Present on Admission: Exempt diagnoses or External Cause of Morbidity codes – report as blank (eliminate allowing “1” or “E”).
- Other Procedures: Allow up to 24 codes to be reported (currently 20 allowed).
- External Causes of Morbidity: Allow up to 12 codes to be reported (currently 5 allowed).
- Total Charges: Increase to 8 digits (currently 7 digits).
- ED/AS Total Charges: Add to the ED/AS dataset.

We encourage participation in the regulatory process. Please share this information with anyone who may be interested.

Correct Reporting of Homeless

Recently it was discovered through inconsistencies in data reporting that many facilities are not reporting ZZZZZ (IP) or 99999 (ED/AS) for the ZIP Code of their homeless patient population.

After inquiries were made to facilities, a variety of causes were cited; these included system issues, admission practices, and the assumption that inpatients that were discharged to a home or care setting should no longer be reported as *Homeless*.

Regulation states that the ZIP Code of the **patient's usual residence** must be reported. In the case of homeless patients, **Hospitals shall distinguish the "homeless" (patients who lack a residence) from other patients ... by reporting the ZIP Code of homeless patients. (Section 97219)** Using the address of the hospital, a third party payer, or a billing address do not qualify as a patient's "usual address." The intent of the regulatory language has been to report *Homeless* if the patient was homeless at admission. Part of the proposed 2019 regulatory package noted on page 1 includes more explicit language to report *Homeless* based on patient status at admission.

MIRCal analysts are contacting facilities that appear to be misreporting their homeless patient population. In cases where a facility's reporting practices conflict with regulatory requirements, a modification will be placed on the data sets affected. Please assist your analyst by answering their inquiries promptly.

Additionally, in the future a new edit will be placed on records that report a diagnosis code consistent with homelessness but do not have a *Homeless* ZIP Code reported.

If your facility's January – June 2017 inpatient data submission for ZIP Code is incorrect, approval will not be given until the ZIP Code data has been validated. Please review your collection and reporting process for your homeless patients and ensure they are being reported correctly.
