8. 2017-2018 CCORP Hospital and Surgeon Outcomes Preliminary Report - review of physician statements – Action Item

- Health and Safety Code §128750 requires OSHPD to provide preliminary outcome results to physicians and allows them to submit a statement if they believe that their risk-adjusted outcome did not accurately reflect the quality of care they provided. Any physician not satisfied with OSHPD's conclusion reached in response to their statement may request that the Panel review the statement and the conclusion of OSHPD. The Panel will make a determination in each case. Health and Safety Code §128750 requires that individual physician identities not be revealed to the Panel.
